

Liability Waiver

1. I wish to participate as a passenger on the recreational water transfer being operated by Sandals St. Vincent and the Grenadines, and I acknowledge that my participation on water transfer is completely voluntary.
2. I UNDERSTAND THAT THERE ARE INHERENT RISKS INVOLVED WITH BOATING, including, but not limited to equipment failure, perils of the sea, harm caused by other vessels, acts of fellow participants, entering and exiting the water, boarding or disembarking boats, and activities on the docks.
3. I fully assume responsibility for my own safety (including, without limitation, following all directions of the boat's captain and crew) while participating on the water transfer and verify that I am physically able to participate.
4. I fully understand that the involved boat has no medical facilities onboard and that in the event of illness or injury appropriate medical care potentially could be summoned by radio and treatment will be delayed until I can be transported to a proper medical facility. I agree in advance to these conditions.
5. No individual associated with SANDALS RESORTS INTERNATIONAL, LTD, SANDALS RESORTS INTERNATIONAL 2000, INC., GORSTEW, LTD., BUCCAMENT BAY MANAGEMENT LIMITED d/b/a SANDALS ST. VINCENT & THE GRENADINES and UNIQUE TRAVEL CORP. and its affiliates, including, but not limited to, UNIQUE VACATIONS, LTD. and UNIQUE VACATIONS, INC.
6. SANDALS RESORTS INTERNATIONAL, LTD, SANDALS RESORTS INTERNATIONAL 2000, INC., GORSTEW, LTD., BUCCAMENT BAY MANAGEMENT LIMITED d/b/a SANDALS ST. VINCENT & THE GRENADINES and UNIQUE TRAVEL CORP. and its affiliates, including, but not limited to, UNIQUE VACATIONS, LTD. and UNIQUE VACATIONS, INC., has not made any express or implied representation to me that they or the boat's crew can or will perform safe rescues or render first aid. In the event I show signs of distress or call for aid I would like assistance and will not hold any person or entity responsible for their actions in attempting the performance or rescue or first aid.

Having read this wavier, I agree to RELEASE from LIABILITY and HOLD SANDALS RESORTS INTERNATIONAL, LTD, SANDALS RESORTS INTERNATIONAL 2000, INC., GORSTEW, LTD., BUCCAMENT BAY MANAGEMENT LIMITED d/b/a SANDALS ST. VINCENT & THE GRENADINES and UNIQUE TRAVEL CORP. and its affiliates, including, but not limited to, UNIQUE VACATIONS, LTD. and UNIQUE VACATIONS, INC., along with its respective officers, directors, employees, owners, members, managers, affiliates, agents, representatives, attorneys, heirs, personal representatives, successors and assigns, all

individuals associated, and all individuals and entities having an interest in the boat being used for the water transfer vessel, from any and all liability, claims, demands, equitable relief, damages, costs, expenses, and causes of action of any kind or character, of any type or nature whatsoever (including negligence), arising out of the transfer.
